Newfound Area Nursing Association (NANA) actively participates in the Central New Hampshire Health Partnership (CNHHP) facilitating the development and implementation of the Community Health Improvement Plan. NANA recently became an active member of the Community Health Services Network, LLC (CHSN) to establish an integrated delivery network to build mental health and substance use disorder treatment capacity, improve care transitions,

and enhance provider integration and collaboration. NANA attends regular scheduled meetings: CNHHP Board Meetings for general planning, CHSN, Strategic Prevention Framework/Bridges to Prevention/Newfound Children's Team Meetings for alcohol use prevention in first user teens and young adults (21-35) binge drinking and childhood obesity; Rural Outreach Planned Care Project/ServiceLink/Newfound Area Senior Services/Central New Hampshire Health Partnership/Bristol Day Away Social Day Care Program for access to healthcare and to match services/resources to clients' specific needs; Central New Hampshire Health Partnership - Greater Plymouth area for emergency preparedness; and Home Care Association of New Hampshire/Visiting Nurse Association of America for legislative advocacy.

Newfound Area Nursing Association will increase access to medical care among community residents through fiscal utilization and community care shared sliding fee programs and promotion of public awareness of community health initiatives. NANA will facilitate awareness, availability and access to services and target coordination and outreach to individuals and populations based on observed utilization patterns. NANA will promote early identification and intervention to increase access to mental health care among isolated elderly, adolescents, people with disabilities, and young families through well child clinics and home visits. NANA will support education of policy makers regarding the cost effectiveness of in-home care compared to residential placement.

Methods employed in the assesment included a series of community discussion groups convened and moderated by members of the Central New Hampshire Health Partnership and review of available population demographics and health status indicators to update a more comprehensive community health needs assessment completed in 2011.
