Re: Notice of Data Breach

To Whom It May Concern:

Our office represents Guilford Technical Community College (GTCC). We are writing to provide you with notice of an incident that may impact the security of personal information relating to eight (8) New Hampshire residents. By providing this notice, GTCC does not waive any rights or defenses regarding the applicability of New Hampshire law or personal jurisdiction. The investigation into the incident is ongoing and this notice will be supplemented with any material facts learned subsequent to its submission.

Background

On September 13, 2020, GTCC determined it was the victim of a ransomware attack and certain systems within GTCC's environment were encrypted as a result. Upon detection of the ransomware, GTCC immediately launched an investigation, with the assistance of leading cybersecurity experts, the Federal Bureau of Investigation, and other state agencies, to determine what happened and to remediate the attack. As part of this investigation, it was determined that the responsible cybercriminal(s) had access to GTCC systems between August 5, 2020 and September 13, 2020, and that personal information may have been accessible to the cybercriminal(s) as a result.

The forensic investigation was unable to identify the extent of personal information, if any, impacted as a result of the incident. However, recent developments suggest that the cybercriminal(s) did gain access to certain personal information within GTCC's environment. As a result, on October 26, 2020, GTCC conducted a thorough review to identify, out of an abundance of caution, all individuals that may be impacted as a result of the incident. The personal

information potentially impacted by this incident relates to current and former staff, faculty, and students, and includes name in addition to one or more of the following data elements: Social Security number, medical insurance information, pay and withholding details, and direct deposit information (financial account number and routing number).

Notice to Residents

GTCC mailed written notice of this incident to your state residents on November 5, 2020, in substantially the same form as the letter attached as Exhibit A.

Steps Taken By GTCC

GTCC takes this incident and the security of information seriously. In addition to taking the steps detailed above, GTCC is reviewing its policies and procedures and implementing additional safeguards to better protect against a similar incident from occurring in the future. GTCC has also moved its main systems and applications to a more secure cloud environment and will transition additional applications and systems to a cloud environment in the coming weeks. GTCC is also offering all potentially impacted individuals with two (2) years of complimentary credit monitoring and identity restoration services with Experian, as well as additional information on how to protect against identity theft and fraud. In addition to providing this notice to your office, GTCC has provided notice of this incident to certain other state regulators and the consumer reporting agencies as required.

Re: Notice of Data Breach

Dear Sample A Sample,

Guilford Technical Community College (GTCC) is writing to notify you of a recent incident that may impact your personal information.

What Happened? On September 13, 2020, GTCC determined it was the victim of a ransomware attack. As a result, certain systems within our environment were encrypted. We immediately launched an investigation, with the assistance of leading cybersecurity experts, the Federal Bureau of Investigation, and other state agencies to determine what happened and to remediate impacted systems. As part of the investigation, it was determined that the responsible cybercriminal(s) had access to GTCC's environment between August 5, 2020 and September 13, 2020, when GTCC discovered the attack, and that your personal information may have been accessible to the cybercriminal(s) during that time as a result.

What Information Was Involved? The forensic investigation was unable to identify whether or not your personal information was impacted by the ransomware attack. However, recent events suggest that the cybercriminal(s) did gain access to certain personal information within our environment. We are still unable to confirm the extent of personal information accessed by the cybercriminal(s) and you should take action as if your information was accessed. After a thorough review, we determined that the following information about you may have been accessible to the cybercriminal(s): name, address, and Social Security number. If you provided GTCC with your financial account information for direct deposit, this information may have also been accessible.

What Are We Doing? We take this incident and the security of your information seriously. In addition to taking the steps detailed above and providing this notice to you, we are reviewing our policies and procedures and implementing additional safeguards. We have moved our main systems and applications to a more secure cloud environment. In the coming weeks, we will also introduce new technological safeguards throughout GTCC's environment to better protect against similar incidents in the future. We are also offering you two (2) years of complimentary credit monitoring and identity restoration services with Experian. We are also notifying certain state regulators and consumer reporting agencies of this incident as required.



What You Can Do. You can review the enclosed Steps You Can Take To Protect Your Information, which contains instructions on how to enroll in the complimentary credit monitoring and identity restoration services, as well as includes additional information on what you can do to better protect against the possibility of identity theft and fraud, if desired. Please note that while GTCC will cover the cost of the identity protection services, you will need to complete the enrollment process.

The call center is available Monday through Friday, 6:00 am to 8:00 pm PST, and Saturday and Sunday, 8:00 am to 5:00 pm PST.

Enroll In Credit Monitoring: We are offering a complimentary two (2) year membership of Experian's lentity Works SM. This product provides you with superior identity detection and resolution of identity theft. To activate your membership and start monitoring your personal information please follow the steps below:

- Ensure that you enroll by: January 31, 2021 (Your code will not work after this date.)

If you believe there was fraudulent use of your information and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent at (833) 256-3157. If, after discussing your situation with an agent, it is determined that Identity Restoration support is needed, then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition). Monitor Your Accounts: We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity or errors.

Check Credit Reports: Under United States law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus. You may also contact the three major credit bureaus directly to request a free copy of your credit report.

Place A Security Freeze: You may place a security freeze on your credit reports, free of charge. A security freeze prohibits a credit reporting agency from releasing any information from a consumer's credit report without written authorization. However, please be aware that placing a security freeze on your credit report may delay, interfere with, or prevent the timely approval of any requests you make for new loans, credit mortgages, employment, housing, or other services. You will need to place a security freeze separately with each of the three major credit bureaus if you wish to place a freeze on all of your credit files. In order to request a security freeze, you will need to supply your full name, address, date of birth, Social Security number, current address, all addresses for up to five previous years, email address, a copy of your state identification card or driver's license, and a copy of a utility bill, bank or insurance statement, or other statement proving residence. Place A Fraud Alert: At no charge, you can also have the three major credit bureaus place a "fraud alert" on your file that alerts creditors to take additional steps to verify your identity prior to granting credit in your name. Note, however, that because it tells creditors to follow certain procedures to protect you, it may also delay your ability to obtain credit while the agency verifies your identity. As soon as one credit bureau confirms your fraud alert, the others are notified to place fraud alerts on your file. Should you wish to place a fraud alert, or should you have any questions regarding your credit report, please contact the credit reporting agencies.

Review Additional Resources: If you believe you are the victim of identity theft or have reason to believe that your personal information has been misused, you should contact the Federal Trade Commission and/or your state Attorney General. You can obtain information from these sources about additional steps you can take to protect yourself against identity theft and fraud, as well as information on security freezes and fraud alerts. Further, pursuant to the Fair Credit Reporting Act, the consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
