Data Security Incident

Dear Attorney General Foster:

We represent Technical Needs North, Inc. ("Tech Needs"), located in Salem, New Hampshire, with respect to a potential data security incident described in more detail below. Tech Needs takes the security and privacy of the information in its control very seriously, and has taken steps to prevent a similar incident from occurring in the future.

# 1. Nature of the security incident.

On March 6, 2018, Tech Needs discovered that it had inadvertently misaddressed the IRS Form 1095-C Affordable Care Act health coverage confirmation forms to other employees. Tech Needs immediately took action and conducted an investigation to determine what information may have been disclosed. As a result of its investigation, it learned that personal information, which included names and Social Security numbers, may have been disclosed. No financial account or transaction information was involved in this incident.

# 2. Number of New Hampshire residents affected.

A total number of fifty-three (53) New Hampshire residents may have been potentially affected by this incident. Notification letters to these individuals were mailed on April 19, 2018, by first class mail. A sample copy of the notification letter is included with this letter.

#### 3. Steps taken.

Tech Needs has taken steps to prevent a similar event from occurring in the future, and to protect the privacy and security of potentially impacted individuals' information. This includes implementing additional measures to prevent the inadvertent mailing of employee personal information, such as adding audit steps to verify that any mailings have the correct addresses. Tech Needs has also provided potentially impacted individuals with identity theft restoration and credit monitoring services for 12 months at no cost to the individual, through Kroll. Notice is also being provided to the credit reporting agencies.

We take the security of all information very seriously, and sincerely apologize for any inconvenience this incident may cause. This letter contains steps you can take to protect your information, and resources we are making available to you.

On March 6, 2018, we discovered that we inadvertently misaddressed the IRS Form 1095-C Affordable Care Act health coverage confirmation forms to other employees. We immediately took action and conducted an investigation to determine what information may have been disclosed. As a result of our investigation, we learned that your personal information, which included your name and Social Security number, may have been disclosed. No financial account or transaction information was involved in this incident.

While we have no evidence of misuse of your information, out of an abundance of caution we are providing you with resources to help protect your identity. We have secured the services of Kroll to provide identity monitoring at no cost to you for one year. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data. Your identity monitoring services include Credit Monitoring, Web Watcher, Public Persona, Quick Cash Scan, \$1 Million Identity Fraud Loss Reimbursement, Fraud Consultation, and Identity Theft Restoration.

# Additional Important Information

# For residents of Hawaii, Michigan, Missouri, Virginia, Vermont, and North Carolina:

It is recommended by state law that you remain vigilant for incidents of fraud and identity theft by reviewing credit card account statements and monitoring your credit report for unauthorized activity.

### For residents of Illinois, Iowa, Maryland, Missouri, North Carolina, Oregon, and West Virginia:

It is required by state laws to inform you that you may obtain a copy of your credit report, free of charge, whether or not you suspect any unauthorized activity on your account. You may obtain a free copy of your credit report from each of the nationwide three credit reporting agencies. To order your free credit report, please visit www.annualcreditreport.com, or call toll-free at 1-877-322-8228. You can also order your annual free credit report by mailing a completed Annual Credit Report Request Form (available at https://www.consumer.ftc.gov/articles/0155-free-credit-reports) to: Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA, 30348-5281.

#### For residents of lowa:

State law advises you to report any suspected identity theft to law enforcement or to the Attorney General.

#### For residents of Oregon:

State laws advise you to report any suspected identity theft to law enforcement, including the Attorney General, and the Federal Trade Commission.

#### For residents of Maryland, Rhode Island, Illinois, and North Carolina:

You can obtain information from the Maryland and North Carolina Offices of the Attorneys General and the Federal Trade Commission about fraud alerts, security freezes, and steps you can take toward preventing identity theft.

## For residents of Massachusetts:

It is required by state law that you are informed of your right to obtain a police report if you are a victim of identity theft

#### For residents of all states:

Fraud Alerts: You can place fraud alerts with the three credit bureaus at one of the three major credit bureaus by phone and also via Experian's or Equifax's website. A fraud alert tells creditors to follow certain procedures, including contacting you, before they open any new accounts or change your existing accounts. For that reason, placing a fraud alert can protect you, but also may delay you when you seek to obtain credit. The contact information for all three credit bureaus is below.

Monitoring: You should always remain vigilant and monitor your accounts for suspicious or unusual activity.

Security Freeze: You also have the right to place a security freeze on your credit report. A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you need to make a request to each consumer reporting agency. You may make that request by certified mail, overnight mail, or regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. The consumer reporting agency may charge a small fee to place, life, or remove a freeze, but is free if you are a victim of identity theft or the spouse of a victim of identity theft, and you have submitted a valid police report relating to the identity theft incident to the consumer reporting agency.
