

**RE: Notification of Security Breach**

Dear Mr. Foster:

I am writing on behalf of Uber Technologies, Inc., to inform you of a security incident involving unauthorized access to electronic files in a proprietary Uber database by a party unaffiliated with Uber. The files contained names and driver's license numbers of individuals who have driven on the Uber platform. On September 17, Uber discovered that information potentially enabling access to this database had been available without access restrictions. Uber immediately changed the access protocols for the database, effectively removing the possibility of unauthorized third party access.

Uber subsequently determined that during the period this information was potentially accessible, database files were accessed only once by a third party unaffiliated with Uber, on May 13, 2014. Subsequent investigation has been unable to identify the third party with certainty, although we have no indication that the information has been misused. Uber is sending notification of the incident to all individuals whose information was contained in the files, including approximately 15 residents of your state.

Please find enclosed a copy of the notification that will be sent to the affected individuals starting today.



I'm writing to let you know that one of Uber's databases was accessed by an unauthorized third party and that as an Uber driver partner your name and driver's license number was contained in the database.

We discovered in September that information allowing someone to access the database had been available without intended access restrictions. We immediately ensured that the database was no longer accessible using that information and have taken additional safety measures to protect your information. Our investigation showed that the database was accessed only once by a third party, on May 13, 2014. We have not received any reports of actual misuse of information as a result of this incident, but Uber recommends that you monitor your credit reports for fraudulent transactions or accounts.

To help protect your identity and monitor credit reports, we are offering a complimentary one-year membership of Experian's® ProtectMyID® Alert. This product helps detect possible misuse of your personal information and provides you with superior identity protection support focused on immediate identification and resolution of identity theft. 3. PROVIDE Your Activation Code: ABCDEFGHIJKL

Once your enrollment in ProtectMyID is complete, you should carefully review your credit report for inaccurate or suspicious items. If you have any questions about ProtectMyID, need help understanding something on your credit report or suspect that an item on your credit report may be fraudulent, please contact Experian's customer care team at (877) 297-7780.

### Additional Steps You Can Take

You may also contact the credit reporting agencies directly to put in place a fraud alert or a security freeze. A fraud alert will notify any merchant checking your credit history that you may be the victim of identity theft and that the merchant should verify the application. Contacting any one of the three agencies will place an alert on your file at all three. A security freeze restricts all creditor access to your account, but might also delay any requests you might make for new accounts. Ask the credit reporting agencies for their specific procedures regarding security freezes.
