1           2 Application. The changes in state representative districts established by this act shall not  
2 affect constituencies or terms of office of representatives presently in office. The state representative  
3 districts established by this act shall be in effect for the purpose of electing representatives at the  
4 2012 state general election. If there shall be a vacancy in a state representatives district for any  
5 reason prior to the 2012 state general election, the vacancy shall be filled by and from the same state  
6 representative district that existed for the 2010 state general election. No provision of this act shall  
7 affect in any manner any of the proceedings of the membership of the house of representatives of the  
8 general court that assembled for a biennial session in January 2011.

9           3 Effective Date. This act shall take effect upon its passage.

AMENDED ANALYSIS

This bill establishes new state representative districts in accordance with the latest federal decennial census.
