SUPPORTING AFFIDAVIT For REQUEST To ISSUE ARREST WARRANT

INSTRUCTIONS: A person seeking an arrest warrant shall appear personally before any Justice or Justice of the Peace, and shall give an affidavit in the form herein after prescribed. The affidavit shall contain facts. Information and circumstances upon which such person relies to establish probable cause for the issuance of the warrant, and the affidavit may be supplemented by oral statements under oath for the establishment of probable cause. The person issuing the warrant shall retain the affidavit and shall make notes personally of the substance of any oral statements under oath supplementing the affidavit or arrange for a transcript to be made of such oral statements.

RSA 318-B:2 UNLAWFUL SALE OF A CONTROLLED DRUG

It shall be unlawful for any person to manufacture, possess, have under his control, sell, purchase, prescribe, administer, or transport or possess with intent to sell, dispense, or compound any controlled drug, or controlled drug analog, or any preparation containing a controlled drug, except as authorized in this chapter.

On January 30th, 2012, the NHAGDTF initiated an investigation into the illicit sales of Oxycodone Hydrochloride in the Town of Greenland.


Using a confidential informant, detectives with the NHAGDTF arranged to purchase 10 Oxycodone Hydrochloride pills from BRITTANY TIBBETTS DOB [REDACTED]/85.

During the daytime hours, the confidential informant was brought to 517 Post Road in Greenland, NH by an undercover detective. The confidential informant went inside 517 Post Road in Greenland, NH and purchased 10 30mg pills for the sum of \$250.00 in documented NHAGDTF funds from TIBBETTS.

The confidential informant then immediately came out and gave the undercover detective the purported pills.

The Oxycodone Hydrochloride 30mg. The Oxycodone Hydrochloride 30mg has been packaged accordingly and will be sent to the New Hampshire State Police Forensic Laboratory for analysis.

Based on the foregoing information I have reason to believe that **BRITTANY TIBBETTS** did commit the crime of **Sale of a Controlled Drug**.


