In accordance with RSA 30-B:12, the Grafton County Commissioners conducted a semiannual tour/inspection of the Department of Corrections on October 26, 2021.

During the course of our tour, we met with the DOC Substance Abuse Program Director and discussed the variety of inmate programming within the facility, substance abuse among the inmate population and our medicated assistance treatment protocols. We met with inmates in their units, discussed any concerns they had and had conversations with the Superintendent, Captain, Security Lieutenant and Community Corrections Lieutenant about the daily operations of the Jail.
